TERMS & CONDITIONS

- ◆ Fuel Policy: The vehicle will be supplied with a full tank of 90-octane petrol and must be returned in the same condition.
- ◆ Additional Drivers: No additional drivers are permitted. In case of an emergency, the Renter must notify the owner

immediately.

- ◆ Vehicle Return: The vehicle must be returned with a full tank of 90-octane petrol and free from damage.
- ◆ Traffic Fines: The Renter is responsible for all traffic fines and penalties incurred during the rental period.
- ◆ Cleaning Fee: If the vehicle is returned in an unclean condition, a US\$50.00 cleaning fee will be applied.

DAMAGE RESPONSIBILITY

The Renter is responsible for any damage to the vehicle during the rental period. In the event of damage, the Rental Company reserves the right to apply the security deposit toward repair costs. Any repair costs exceeding the deposit amount will be billed to the Renter and must be paid within 14 days of the return date.

CANCELLATION POLICY

Cancellations must be made at least 10 business days prior to the rental start date. Cancellations made within 10 business days of the start date will result in forfeiture of the security deposit.

RENTER'S RESPONSIBILITIES

The Renter agrees to:

1. Provide accurate information. Any breach of this term may result in legal action and associated legal fees being charged to the Renter.
2. Drive safely and obey all traffic laws of Jamaica.
3. Report any accidents or incidents to RC Endless Possibilities within 24 hours.
4. Cooperate fully with insurance investigations as required.
5. Not use the vehicle for hire, sub-leasing, or any commercial purpose.
6. Not permit any other person to operate the vehicle, or use it for any illegal activity.
7. Not consume alcohol or smoke while operating the vehicle.
8. Return the vehicle in the same condition it was given. If returned in an unclean condition, a US\$50.00 cleaning fee will be charged.

GOVERNING LAW

This agreement shall be governed by the laws of Jamaica. The Renter acknowledges that any disputes arising from this agreement will be subject to the jurisdiction of the Jamaican courts.
